

We would like to remind exhibitors of the I.F.T. Rules and Regulations for the Sections Suppliers Nights:

1. Must be limited to table top displays
2. Permitted at table top displays:
 - a) Educational sales literature;
 - b) Samples of ingredients, additives or food products;
 - c) Sales premiums, souvenirs, handouts;
 - d) Instruments and/or equipment (if they can be self supporting and set on the table)
3. Prohibited at table top displays;
 - a) Free standing floor displays;
 - b) Table top displays that exceed 5 ft. above the table;
4. Only Section-provided exhibitor standard identification signs are allowed.
5. Exhibit company may contract for a maximum of two continuous tables.
6. No dismantling of the set is permitted before the end of the event.
(New show hours are from 4:00pm – 7:30pm)
7. By completion of the Supplier's Night Registration, the exhibitor agrees to conform to the rules of the exhibition.
8. Refund Policy - There will be no refunds within 14 days of the event. Refunds prior to 14 days will be 50% of original payment.

The I.F.T. Regional Sections and its agents and employees assume no risk and by the acceptance of this agreement the exhibitor expressly releases them of and from any and all liability for damage, injury, or loss to any person or goods, from any cause whatsoever.

Upon receipt of your cheque and copy of your registration, an email or fax confirmation will be sent to you. Tables are designated in the order of cheque payment.

Electrical outlets are limited and are provided on a first come basis. Power bars and extension cords are the registrant's responsibility. They are not provided nor are they available from BCFT or from the hotel.
